The proposed bricks are new handmade ones, made by Imperial. They are a very good match and were found in a reclamation yard. The bricks are the same size and decent colour match, even if the picture does show that the new ones are slightly more orange. They will be used just on the internal skin where they won't be seen, as they will be hidden by an internal plaster finish. The reason for this is that some of the proposed bricks are cleaner than the ones salvaged from site and we want to keep the external looking as honest and true as possible.
