Dear Mr Hart,

Thank you for your emails and for your patience whilst I was away last week involved in a Public Inquiry.

On 01 March we issued our Reg 77 decision (CD/24/0433) which permitted the stationing of up to 100 standard sized (5m x 9m) pitches at Alderman Peel High School between 01 Jan 2024 and 31 Dec 2024.

You now want to increase the number from 100 to 150 or 160 standard sized pitches for this year. Since issuing the March decision, the GIRAMS tariff has increased (in line with inflation) and each plot is now approx. £2.21 meaning

that for an additional 50 standard units the addition to pay would be £110.59 or for an additional 60 units it would be £132.70.

If you can arrange with Ben Rowe to make the above payment (based on the expected addition) and if you can confirm that the location is the same as before we can then set up a new Reg 77 application and I can cross refer to your earlier reference when making the new decision. On this occasion we can waive the £30 Reg 77 fee.
