The large conifer is just outside our boundary on Council land however it is very tall and the branches are spreading across our land, in particular the driveway. We would like to cut this back to stop damage to our cars. Ideally we would love it to be cut back and reduced in height but not sure if that's two applications. Certainly for this one we want to cut the overhanging branches that encroach onto our property.

Its a large conifer to the right hand side of our property on council land that overhangs our boundary and main drive.. We want to cut the branches back on our land to protect our cars. If possible we would like the tree reducing in height, Conifers are shallow rooted and if this fell towards the property it would cause significant damage.
