 The tree was planted some 30 years ago by the owners of 17, Cranbrook Road to celebrate the birth of their daughter. The owners applied to have it reduced in size some 20 years ago as it had grown much bigger than anticipated. The tree overhangs 19, Cranbrook Road cutting out light, creating damp conditions so that the tarmaced parking area and cars are covered in moss, debris and bird droppings that have to be cleared monthly. The tree exceeds the height of the house by 7 metres causing the accretion of moss in the gutters which have to be cleared three times a year. The tree is of disproportionate size to others in the area. A previous request to remove branches overhanging 19, Cranbrook Road has been rejected but, before the rejection, the planning officer indicated that he would permit 2 metres to be removed.

The tree is a silver birch and the specification of work is the removal of 2 metres of the overhang as indicated in the attached drawing.
