An acacia tree growing in our back garden on the border of the neighbours garden is causing damage to the fence panels and the roots are lifting their patio on the other side of the fence (pics and letter from neighbour attached as well as map showing location of the tree) The tree unfortunately needs to be felled and the roots sorted so we can relay the paving and out right the damage. We have contacted a tree surgeon who has previously carried out work at the property and they agree that this tree is causing the issue.
