There are four leylandii trees on the southern boundary of my property that have grown to a height of approximately 15 metres. I want to reduce the height of two of them (1&2 on the sketch plan) by approximately 50%, reduce the height of a third one by approximately 60% (4 on the sketch plan) and completely remove the fourth one (3 on the sketch plan) because it has quite an acute lean to it and it isn't very visible as it's growing behind one of the other leylandiis.

There is a maple of approximately 12 metres (light green circle on the sketch plan) on the southern boundary that I want to totally remove. This is because my next door neighbours had some tree work done to it a while ago which has turned it into an eyesore.

There is a willow in my front lawn (yellow circle on the sketch plan) which has reached a height of approximately 9 metres. I want to reduce its height by approximately 2 metres.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
