One Eucalyptus tree at the bottom of my garden which grows excessively quickly and overhangs my neighbour at 23 as it sits on our fence boundary. It also causes a problem as its height touches the telegraph lines above it. Permision has been granted for previous application to crown by 50% due to its fast growth and cost. I am applying to Crown this tree once again by 50% please.
