G1, consisting of 9 Beech trees and Laurel, (laurel probably not protected.) fell cut to ground level, Beech has decay in most stems and dropping dead wood in road and garden constantly, risk to the highway stems fails. plan to replant and start again an new Beech or Simliar hedge.

T1 Maple, repollaard back to previous points, cutting to kugckles, leaving finish height 6m aprox. from garden level. nearing utility lines,
