Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

We wish to remove the bulk of the Holly tree that is located in our front garden, embedded within a 'holly' hedge that runs the width of the garden facing the road. The tree has become very dense and unsightly probably due to years of neglect by previous owners and now continues to grow taller as well as 'sprouting' in all directions; it becoming a specimen offering very low amenity value.

The tree is beginning to filter light due to its dense nature and affect our main bedroom window somewhat blocking the view of other trees across the road that do provide significant amenity value. The trunk /root is growing very close to our Mains water meter and pipe into the house; our concern being that if left to continue growing it will at some stage cause a ruptured pipe.

As the tree is embedded with a holly hedge so the proposal is to initially cut the bulk of the tree leaving the trunk within the hedge row but some inches below the hedge height. Further along the hedge there have been two other trees (probably holly) that have been truncated to just a few feet high; by previous owners.

We are this year renovating our front garden replacing a worn out drive area with a permeable gravel design and intend to create flower beds around the garden and to plant a replacement tree in the corner at the opposite end of the property well away from the entrance gates and house. It is intended that a far more interesting and attractive tree will be planted that will not grow beyond 3m, being more in keeping with our overall garden size.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
