On the boundary between the Joules Brewery site/Stag rear garden & neighboring property there are a cluster of 3 self set sycamores with codominant stems (G1 on Birdseye plan). The location of the trees do not add any amenity value to any surrounding sites, the trees are growing through the boundary wall and their routes are now presenting a risk of damaging structural surroundings as they have outgrown their space. They will cause damage to the adjacent brewery buildings and are also at risk or splitting as time goes on due to the weak structure of the tree caused by the co-dominant stems.

We are looking section fell to ground level and rip out the trees in question. We will be looking to replant near the area in a better location with alternative such as cherry tree.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
