Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

- T1 English Oak Crown height reduction 2-2.5m from 16m to 14.5-14.0m, and a lateral reduction of the South and Southwest side by 1.5-2m from 8m to 6.5m-6.0m. Remove deadwood and crown clean.
- Works are requested to immediate the risk through altered exposure, given the trees proximity to house, after the two Pine trees were removed on the North to Northeast side. The lateral reduction is requested to re-balance the crown after the reduction of the lateral branches, on South to Southeast side over the property, and balance with the upper canopy reduction.
- T3 Yew Crown reduction, reducing height and spread by 1-1.5m. Works are requested as the trees are overbearing for space.
- T4 Red Oak Re-pollard back to previous points. Works are requested as arboricultural management of previously pollarded tree.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
