A single silver birch tree located at the front of our property close to the house and on the boundary with our neighbours property. The tree is approximately 40 years old and no longer has new leaves or growth in the top 3rd of the tree. Our tree surgeon has advised that it has died at the top and probably only has a couple of years left for the whole tree. Dead branches frequently fall onto our drive and onto the neighbours side. The tree is becoming more of a danger during higher winds and this request is to fell the tree before damage or injury occurs.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
