Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1-Scots Pine: The tree has an acute bend circa 7m from ground level with the head and remaining foliage above the bend leading the excessive wind loading. The tree has historically been refused for removal yet it was noted that lesser works could be undertaken. Undertake an upper scaffold branch reduction of no more than 1.2m from the tips inwards. This will reduce the wind loading which will mitigate the risk of failure.

T2-Scots Pine: At the point of bifurcation at circa 10m there is a heavily included union. There is substantial weight above this defect and if left unmanaged there is a risk of catastrophic failure as a result. Undertake an upper crown reduction only of no more than 1.2m from the tips inwards via the removal of tertiary and secondary branches only.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
