- T1 Silver Birch - Crown reduction to include - Reduce all of the lateral regrowth back to boundary fence line by 3m, to reduce road and pathway overhang, cutting to strong secondary growth, shape and balance. New shape indicated in red on image.
- T2 Rowan - Crown reduction to include - Reduce all the lateral regrowth back boundary fence line by 3m, reducing pathway and road overhang, cutting to strong secondary growth, shape and balance. New shape indicated in red on image.
- T3 Cherry - Crown reduction to include - Reduce all the lateral regrowth back boundary fence line by 3m, reducing pathway and road overhang, cutting to strong secondary growth, shape and balance. New shape indicated in red on image.
- T4 Silver Birch - Crown reduction to include - Reduce all the lateral regrowth back boundary fence line by 3m, reducing pathway and road overhang, cutting to strong secondary growth, shape and balance. New shape indicated in red on image.
- T5 Sycamore x 3 - Crown reduction to include - Reduce all of the regrowth back to historic reduction points, behind metal fence line, cutting to strong secondary growth, shape and balance. New shape indicated in red on image. Including lower Laurel branches.
- T6 Lime x 6 - Crown reduction to include - Reduce all of the regrowth back to behind metal sports ground fence, cutting back to strong secondary growth, shape and balance. New shape indicated in red on image.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
